The applicant must:

1. Be enrolled at Delaware Technical & Community College in the CUL or FSM program for at least 1 semester.
2. Be in good academic standing with Delaware Tech.
3. Have an average GPA of 3.0 for full or part-time students.
4. Be a returning student after completing 1 semester in FSM or CUL.
5. Complete the enclosed application materials:
 - a. Complete the scholarship essay as per instructions.
 - b. Provide an official transcript of all coursework to date.
 - c. Attach a copy of current resume.

Finalist is selected on the basis of academic achievement, enthusiasm for the hospitality industry and financial needs. Recipients of awards will be invited to attend a meeting of the DTCC Culinary Arts Club to receive their award.

Application deadline is November 20 for the Spring semester and May 20 for the Fall semester.

Two scholarship awards will be \$300 each semester towards tuition and fees for Delaware Tech in the Culinary Arts or Food Service Management program. Proof of payment must be presented. In the event of only one qualified applicant a \$600 scholarship may be awarded. If classes the scholarship is applied to are dropped or recycled by the recipient the college must be reimbursed the scholarship amount.
